Legacy Statement concerning Marriage

The performance of marriage ceremonies is an accommodation to the Body, not an obligation. It is understood that entering into pre-marital counseling does not constitute an agreement or approval to be married here. The pastor performing the wedding must operate in good conscience before the Lord and reserves the right to postpone or deny any ceremony, if he feels it is in the best interest of the couple or the church. Postponement or denial by one member of the pastoral staff will preclude request to any other pastoral staff members. Only after completion of pre-marital counseling can permission be given by a pastor to perform a wedding here. Legacy is not obligated to meet any wedding date request set prior to counseling.

Additional Regulations:

- No smoking inside the church.
- No alcoholic beverages are allowed – the beverage for the toast must be non-alcoholic.
- Please provide birdseeds rather than rice for showering the couple.
- The church will not be responsible for any accidents, thefts of personal items, or damages incurred while utilizing the property.
- In accordance with the number of hours agreed upon, any rehearsals, weddings, etc. extending past the time agreed upon will incur additional charges.
- No tacks are to be used for any reasons in any fixtures and furniture of the church (including decorative bows). All items must be affixed with appropriate floral clips. As a rule, there will be no weddings on Sunday's.
- All decorations (bows, candelabrum, arches, kneeling benches, etc.) **MUST** be removed from the sanctuary immediately following the ceremony. It is **NOT** the responsibility of the Legacy Staff to remove decorations. We recommend that you appoint a person (s) prior to the ceremony to take care of this. Fifty dollars (\$50.00) of the fees will be refunded after the wedding if the Church is cleaned and left in the same condition, as it was when you arrived for your wedding.
- Platform Use: no children are allowed on the platform with the exception of those in the wedding party. No one is allowed to move the musical instruments, etc. without gaining permission from the Legacy Wedding Coordinator at least seven (7) days in advance of the ceremony.
- No church property is to be tampered with, removed, broken down, or rearranged by anyone except the Legacy Wedding Coordinator.



FEES

Fees are non-refundable. Payment is due ten days prior to wedding. Checks should be made payable to CCF church, and presented to the Church Wedding Coordinator. The deposit is non-refundable, even if your wedding is cancelled.

TIMING

Wedding should start no later than five (5) minutes after scheduled time

REHERSAL

You are responsible to ensure that all participants in the bridal party are present at the rehearsal, including all parents of bride and groom, all ushers, bridesmaids, groomsmen, musicians, soloist, flower girl and ring bearer, etc. This ensures that there are no surprises.

Remember to bring the marriage license to the rehearsal.
